## **Chair's Report 2015**

#### 31 and Still Counting

Another year and another Chair's Report! This year has seen the publication of the Liverpool Mayoral Commission on Environmental Sustainability Report Published March and the establishment of a Liverpool Strategic Green and Open Spaces Review Board.

Slightly further afield fracking was rejected by Lancashire County Council and in May we had the General Election with a majority Conservative win but with the Greens gaining a 2.8% increase share of the vote.

However, the Conservative majority has seen some change of direction on some environmental policies – perhaps we are now seeing the influence that the Lib Dems had in coalition?

In the ever increasing cyberspace world of Social Media US President Barack Obama has finally joined Facebook - and used his first posting to issue a warning about climate change. Obama's warning came on the same day it was announced the average global climate for 2015 is on course to be 1°C higher than the global average prior to industrialisation between 1850 and 1900.

And here today we find ourselves at the midpoint of the Conference of Parties 21<sup>st</sup> meeting (COP 21) in Paris, which France is chairing as well as hosting to the United Nations Framework Convention on Climate Change, from 30 November to 11 December 2015. The conference is crucial because the expected outcome is a new international agreement on climate change, applicable to all, to keep global warming below 2°C.

For MET, this year has been one of consolidation and strategic alliances – as you will see throughout this report.

The Trust still continues to function with the active and energetic support of volunteers and the Executive Committee; and financially we continue to be moderately healthy.

This year we supported property management company CBRE's annual Environment Day Envirolive 2015 by providing and manning a stand in their exhibition and hosted the Gather Liverpool session on the Mayoral Sustainability Commission entitled 'Delivering the recommendations of the Mayoral Commission on environmental sustainability'. Professor Nigel Weatherill, Chair of the Commission set out how they reached these recommendations and their hopes for its implementation. Participants also heard how progress is already being made in several areas from key delivery agencies such as Merseytravel and Merseyside Recycling and Waste Authority.

<sup>6</sup>Developing a Natural Health Service – Sherrington Building, University of Liverpool, Tuesday 22<sup>nd</sup> September

Together with the Duncan Society we organised an evening lecture from Paul Nolan OBE Director of the Mersey Forest Team.

The lecture examined some of the wealth of evidence to show how high quality natural environments can support health and wellbeing. How specific programmes such as Green Gym. Forest School, Cycle for Health and Walking for Health, use the natural environment as the basis for their work.

However, these types of intervention are still not integrated fully into the health and social care systems, are often funded as short-term projects and can lack robust assessments of health outcomes. The lecture also featured the work of the newly established Natural Health Service Research Centre of Excellence – no doubt the focus of another event in the years to come.

## **Finance and Other Support for the Trust**

The Trust still receives modest membership fees and still maintains a moderately healthy bank balance, but we cannot continue as we are for many more years as our accounts will attest. A priority for the Trust going forward will be to develop a more strategic fundraising strategy, but more of those ideas later in my report.

Again we have to thank the University of Liverpool for their continuing support in providing office space for the Trust which is a very valuable asset to us.
